Objective: To provide PPE Isolation Suits 'FREE OF COST' to doctors and paramedics.

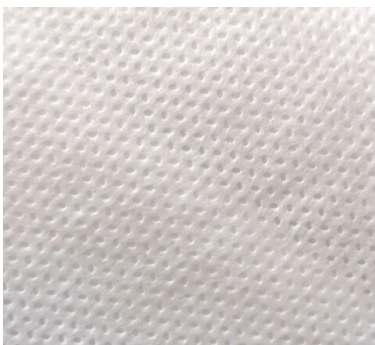


**HELP US HELP OUR FRONTLINE HEROES !**

We are working on developing a very cost effective protective full body suit, including shoe covers, made of 50GSM non-woven polypropylene waterproof fabric. Currently, we are able to produce an isolation suit for PKR 375/piece. Unfortunately, the prices are subject to change due to the fluctuating availability and cost of the required PPE fabric in the market\*\*.



The suits are '**NOT FOR SALE**', and will be supplied to various hospitals and healthcare facilities dealing directly with COVID-19 Patients, through collection of funds and donations.

\*As per research and discussion with various doctors, locally and abroad, disposable suits are recommended during this pandemic. Many hospitals, especially government hospitals, may not provide full support to have re-usable suits laundered as per safety standards and this may compromise all efforts if the suits become infected. Non-woven polypropylene fabric can be washed using bleach for roughly 4-5 times.

\*\*Since January, stocks of PPE have been severely impacted by a global need for products to address the COVID-19 pandemic. This has been exacerbated by export restrictions, disruptions of logistics systems and escalating costs.

\*\*\* We will gather our information before any acceptance. This cause is for healthcare facilities dealing directly with COVID-19 patients and is particularly being made available to isolation wards after consultation with doctors. No suits are available for sale or any commercial purpose.
